

## Fishkill Reinvestigation

January 26, 2013

Present: Investigators Jason, Bev, Kelly and Barbara. Family members: Mike, Michele, [REDACTED].

### Synopsis

- No Evps that we could be sure of were found.
  - There were too many whispers and outside contamination by participants to be definitive on any potential evps.
- Our gear was shut down by outside influences multiple times throughout the investigation that we could find no explanation for.
  - 3 different camcorders were shut off. All had full battery capacity at the time and when repowered up. With the 2 regular Sony camcorders the sound of a physical click was heard and yet the power on was still locked on. The *full spectrum camera* has only 2 ways to turn on/off. Opening/closing the LCD display or pushing and holding the button under the LCD display for approximately 5-10 seconds. You cannot just push the button and turn it off. The button is flush mounted and does not protrude so accidental turn off is impossible. Nothing like this has happened before.
- Spirit box interaction was minimal as was the KII meter interaction. There were times we were told to leave using the spirit box. This was prevalent in the last investigation as well.

- Throughout the evening we did hear voices and noises, however none were captured on any recorders.
- Additionally, on our original walkthrough investigators Bev and Barb saw a small black shadow mass on the main floor 'office' area near the glass door that moved quickly from right to left causing both investigators to jump. We quickly checked the kitchen area but there was no way for it to enter that room. The shadow mass made no noise and moved quickly. We concluded it was no animal but were unable to either debunk it or find a satisfactory explanation.

### Investigation Summary and Recommendations:

Based on the investigation results it would appear that the spirits were either not present or did not wish to participate further.

Since there were several attempts to shut our gear down and the 'get out' responses, it is my opinion that the spirits are no longer interested in communicating with us.

Several things should and can be done by Mike and Michele.

1. If additional contact is desired then inexpensive digital recorders or meters (KII or Ghost meter) can be purchased and used by Mike and Michele. This was discussed by the team with [REDACTED] at the end of the investigation.
2. It is our belief that whatever there was to be found as originally referenced or implied either has been found, is lost in the home still or

removed from the home already. The last could be through sale of items, tossed or actually in someone's home.

3. The fact that a psychic/medium indicated there was something of value does not mean it had monetary value. The value could have been of a personal nature.
4. We believe that the original investigation did yield results that addressed the questions/concerns of Mike and Michele.
  - We received several names that could be traced to former residents in the Fishkill area. These could be related to the voices and shadows heard and seen by Mike, Brian and Michele.
  - We did receive an evp that said 'necklace' and multiple messages via the spirit box for a location 'under the stairs'.
  - We received both evp and spirit box messages acknowledging Mrs. [REDACTED] and possibly Mike's mother [REDACTED]. Some of these messages expressed endearments of "I love you" and "Miss you".

It is possible that the spirits may be tired of the attempts to reach out and contact them. Either they've relayed whatever messages were meant to be delivered or they cannot get the intent of their messages to the family. Spirits do not respond on command nor are they present all the time. They do not provide detailed information as a rule. It is very difficult and takes tremendous effort to reach out to the living. If there is something to be found in the house it could take months to uncover while the remainder of the articles in the house are gone through.

In any case it is not recommended for the team to return at any point in the future. Pirc will be available for any future questions or concerns that Mike and Michele may have and should feel free to contact Barbara.
