1. Introduction

So you want to be a Pirc investigator. There are a few things you need to know before you decide to come on board. The purpose of this application is to explain the steps and commitment required before we welcome you to the PIRC team.

Inside you will get a glimpse of the training you will undergo and the requirements to move into an active member status.

Filling out the application does not guarantee you will automatically start your new investigator training. This application will be held on file pending an opening within the PIRC team.

You are *required* to fill out the Investigator Information and About You attachments and return them with the sign off sheet to me to have your application placed on file. These can be sent as attachments via email to Barbara@pirc-ny.com. (Image or scanned copies are acceptable including the sign off sheet)

2. Starters

Here are a few things you need to know.

- ✦ We are a non-profit paranormal team which means that under no circumstance do we ever charge our clients for our services.
- ✦ Pirc engages in three types of investigations; Paid Events, Residential and Urban.
- ✦ There is absolutely no alcohol or substance use on any investigation. This includes smoking.
- ✦ Pirc has a strict privacy policy.
- ✦ All evidence collected during any Pirc investigation is considered property of Pirc and may not be used, reproduced, edited, transmitted or uploaded to any personal media site, YouTube or any other website without the expressed written permission of the director of Pirc.

We vow to treat our clients, client's home, any entities and each other with respect. We never challenge, provoke or use any aggressive behaviors when conducting our investigations.

Provoking, challenging or aggressive behavior will not be tolerated.

All members will conduct themselves with the highest integrity at all times.

3. About You

Below are some things that we will ask you to provide about you before we consider you for inclusion into our team. (Forms are also on the site. They are required as part of the application)

Have you:

- ▲ Ever used a Ouija board
- ▲ Ever participated in a séance
- ▲ Ever used tarot cards, crystals, dowsing rods or other metaphysical items.
- ▲ Engaged in the black arts or any black arts religion or ritual
- ▲ Engaged in any occult activity this includes Voodoo, Santeria or similar cultural activity
- ▲ Served time in jail or ever been convicted of a felony
- ▲ Ever had a paranormal attachment
- ▲ Ever lived in a haunted house

Are you:

- ▲ A member of any alternative religion
- ▲ Empathetic or Sensitive
- ▲ A Medium
- ▲ Do you have visions or hear voices
- ▲ Religious
- ▲ Under a doctor's care for any medical conditions

Please tell the director if you fit into any of the above categories.

4. Training Program Brief Description

The Pirc training program is designed to aid new members in acclimating into the Pirc team and its investigative process.

Investigations and the review process are an integral part of being a member. The training, investigation review and evp extraction are time consuming but mandatory elements. If you do not have the time to participate then it's best to be honest with yourself about whether this is what you want to commit to.

All new investigators start off in the status category of “New Member Probation (NMP).”¹ The NMP term allows the Pirc Director to evaluate the investigator candidate to see if they will be a positive addition to the Pirc team. NMP status is not the same as the regular ‘probation’ status outlined in the handbook.

4.1. The PIRC training program consists of a probationary period lasting not less than six months.

4.2. Trainees will learn how to:

- ▲ Conduct Evp sessions
- ▲ Listen for evps (electronic voice phenomena)
- ▲ Extract identified evps
- ▲ Perform research for investigations
- ▲ Review video footage (drv & camcorder)
- ▲ Operate the various PIRC equipment.

4.3. All trainees must undergo the equipment orientation training program and know how to operate all Pirc equipment

4.4. Trainees are expected to perform:

- ▲ Case research
- ▲ A minimum of 8 audio reviews and 3 video reviews before attending investigations²

4.5. Trainees must read and sign off³ the following Pirc documents:

- ▲ Pirc Waiver
- ▲ Pirc Code/Rules
- ▲ Pirc Handbook
- ▲ New Investigator Training Manual
- ▲ Any Pirc training sign off not mentioned
- ▲ The Pirc Awareness training guide

4.6. Trainees cannot meet any of the requirements identified on the *probation* list in the Pirc Handbook. Being put on *probation* for any reason during your training process will result in immediate removal from the team.

5. Protection

It is important as investigators that we take the proper precautions to protect ourselves from paranormal attack and attachment. As a group we do perform protection prayers at the start and end of each investigation.

If a new member candidate has opposition to a particular religious affiliation that should be brought to the attention of the director for discussion.

It is not so much what it is you say but your intention. It is acceptable to protect yourself in your own way. We are not trying to sell religion but we want to keep people safe.

If you have an opposition to saying protection prayers in general this is something you must identify prior to starting your training with us.

6. Closing

We want you to enjoy your experiences with the Pirc team.

If you feel for any reason that you cannot commit yourself to the training or investigative process we ask you to be honest with us. The last thing we want is for you to have a negative experience in joining us.

Our training process is designed to help you transition into our team and to learn from our experiences. You may already have some experience but this probationary period is to help you learn our way.

It also provides both of us with the opportunity to see if you will be a good fit.

Each member brings something to the team and we want members to continually grow in their experiences and the investigative process.

Understand that we are a mix of personalities, experiences, religious affiliations, political views and belief systems. Respect the differences and try to avoid conflicts with other team members.

It is our hope that you will enjoy the training process and become a positive addition to our team.
