## Preliminary Investigation Information

Client [REDACTED] and wife [REDACTED] contacted me on March 6, 2014 and complained of hearing voices and footsteps in the house. [REDACTED] has heard a woman screaming. They have [REDACTED] sons, [REDACTED]. [REDACTED] and [REDACTED] have indicated that [REDACTED] has been moody and bossy to the point of almost bullying them all. Given his age it is possible that the onset of puberty is fueling the spirit activity. Both boys have heard noises but [REDACTED] has heard his name and has been scratched. [REDACTED] and [REDACTED] have been scratched as well. [REDACTED] has felt cold spots and had spider web feelings on his face. He also saw a shadow figure out in the yard last year.

[REDACTED] has complained that he has seen the lights flickering but the rest of the family did not see this. [REDACTED] indicated that he has heard [REDACTED] talking to himself but as far as we can tell this is just normal childhood behavior. We have asked [REDACTED] to pay attention if [REDACTED] indicates that 'a friend wants him to do something' or if he starts exhibiting strange behavior. As far as the client knows [REDACTED] is unaware of the activity. Other phenomenon consists of [REDACTED] hearing voices whisper to him in the vent, toys being moved and the sound of cabinet doors.

[REDACTED] collects old [REDACTED] equipment which is outside and may be the source of some of the problem. [REDACTED] has performed much renovation on the house and [REDACTED] indicated they felt the previous homeowner was poor at any renovation or improvement activity. We advised that saying the criticism out loud could be making the entity hostile if it is [REDACTED].

We performed our preliminary on March 13, 2014 during that time we experienced cold spots and heard voices. The last voice was picked up on our digital recorder. <sup>1</sup>

During the preliminary interview we took base readings throughout the living areas, with no EMF activity, even around appliances where one might expect some detection. [REDACTED] had indicated that they had done extensive work on the home over the years and had re-wired the entire electrical system. The home was therefore very well shielded. The [REDACTED] have two young boys who were in the residence during the preliminary, so the initial sweep of the home excluded all of the bedrooms and included only the general living spaces and kitchen.

During our preliminary we told the entity it was unacceptable to touch the children or scratch anyone. Since then the homeowner indicated that the activity has quieted down with no more incidents of anyone being scratched or touched. There have been additional voices and movement of toys. The homeowner indicated that the feeling in the house has changed and that the entity seems to prefer staying in the basement since our visit.

While the homeowner has had friends tell them to ask the entity to leave I believe we can get the entity to go back to being dormant without feeling threatened. The homeowner has saged the residence, used an Ouija board, taken photos and used downloaded apps to try to communicate with the entity. We believe much of the activity is as a result of them trying to mimic what they see on TV and communicate with the entity.

### **Investigation**

The investigation was conducted on March 29, 2014 and it began at approximately 8pm. Present were [REDACTED] and PIRC Investigators Barbara, Kelly and Kevin.

We set up the 4 dvr cameras as follows: #1 master bedroom, #2 dining room (w/no audio), #3 living room and #4 in the basement. All but #2 had audio with them.

Additional digital audio recorders were placed: #2 [REDACTED] room, #5 [REDACTED] room, #6 back room in basement, #7 master bathroom and #8 was carried by Kevin.

The REM pod was placed originally at the top of the stairs and later moved to the landing. The shadow detector was originally placed in the living room but was moved later to the top of the stairs. The shadow detector is very sensitive and we were getting false indications all night whenever a flashlight was shown in its direction; however there were some alarms that were not participant triggered.

Base station was monitored all night long. There were a few notations made throughout the evening which have been reviewed. Throughout the night the team investigated all locations that were of known activity.

After set up the team broke apart into 3 teams;

- Kevin and [REDACTED] – Master Bedroom
- Barbara, [REDACTED] and [REDACTED] - Basement
- Kelly – Monitored Base

The evening started off slow with very little interaction; however from the point of the spirit box session until the end of the night there was a continual interaction using the various devices we employed. The spirit box was set to the fastest scan. The first session was using reverse and a new speaker. This did not yield much in the way of interaction so we switched to a forward scan and a different speaker. While this provided more interaction it also provided a lot more ambient interference from surrounding radio stations.

We employed the help of an EM Pump to help fuel paranormal activity and we did find that interaction between us and the paranormal energies did increase. At one point in the evening several of those present were adversely affected and had to leave the premises momentarily to clear their head and let the sensation pass. It is unknown if these affects were as a result of the excess electromagnetic energy or from paranormal interaction.

I can say definitively that the atmosphere in the home changed in the later evening. The energy in the kitchen changed dramatically and became heavy and caused many of us to experience adverse affects such as hair raising, goose bumps and personality changes. Many of those present picked up empathic influences from the

energies present. While this was interesting and exciting we made a point to explain to the energies present that contact would only be permitted that evening.

We repeatedly commented that at no point would it be acceptable to reach out and touch anyone in the family. While the family is willing to share the space with the energies, they were asked not to go into the children's rooms or areas at any time if the children were present. [REDACTED] and [REDACTED] repeated asked for confirmation of these requests using the KII meter and they received an acknowledgement to their requests several times.

**Special Note on the P-SB7:** Caution should be applied to any responses garnered with any use of the spirit box since the device scans the airwaves and as such it is considered a controversial device. It is hard to definitively say that any words or information received via the spirit box is in fact paranormal. We look for the context of the words received to the question asked. Is the sound or the tone of the voice the same question after question? Is the word heard with music? Does the answer seem logical or more likely random and what could be attributed to a radio program.

When taking those criteria into consideration we must evaluate the words and determine is it more likely a message or communication or that of a random radio station. When we review a spirit box session we extract those pieces we feel are of interest and could possibly be communication. We cannot say that any information or message received during a spirit box session is definitively paranormal but we use the spirit box as a tool to aid us in our goal to communicate with the spirit world. Like all the tools we use, care should be taken to use a critical ear when listening to the 'responses' and take from the session what seems to fit.

Since we do not understand how the spirit world operates we cannot say they are not using the device to communicate, especially since we do receive many responses that appear to fit and are the same voice over many frequencies.

The spirit box was designed by Gary Galka to communicate with his oldest daughter Melissa after she passed. Gary also designed the Mel-8704 and several other paranormal devices to communicate with her.

## Evidence Description

**Photographic:** There was no photographic evidence obtained. This applies to regular, Flir and full spectrum photography.

**Video:** There was no video evidence obtained. This applies to both dvr and full spectrum.

**EVP:** See Appendices # for evp listing by digital recorder and location.

We obtained many evps throughout the night that were of good quality. There were some that I felt provided easier listening if they were enhanced. Any file that is enhanced will be noted as such and a copy of the original, unaltered file will be included for comparison. We always provide a copy of the original file so that you, the client, may listen for their selves if our enhancements change the information in any way. It is not our intention when we enhance a file to alter the information in any way. We only enhance a file to make them easier to hear without the use of headphones.

Spirit box (sb) responses will be included in their specific recorder/location list. Many of the evps and spirit box responses could be heard on multiple recorders. In some cases I've chosen to include the duplicates since sometimes a response can be heard more clearly from a different location.

The numbers that are part of the file name refer to a specific digital recorder number, location and may contain what the Pirc extraction team member thought they heard. Please be aware many people hear different things when listening to evps, the words provided are what that Pirc reviewer thought they heard. You may hear something different. This is quite normal and do not allow yourself to be persuaded if you think you hear something other than what is listed. The format may change slightly from reviewer to reviewer but the meaning is the same. The DR# refers to our digital recorder number, the numbers refer to hr:min:sec (as applicable) extraction location of that file's evp as determined by the Pirc reviewer and a part number (if applicable).<sup>2</sup>

## Personal Experiences:

**Barbara:** I felt the evening progressed well and all participated in the investigation. As the evening progressed and the atmosphere changed, so did the way the participants interacted with the energies. It is my personal feeling that the energies were feeding off the energy, emotion and reactions of those present.

Our group generally processes an investigation using only our equipment, however [REDACTED] is a sensitive and as a guest we allowed her to follow her impressions. It is my impression that the energies in the house were fueled by her assertive questioning and both spiritual and human energy fed off one another.

It is my impression that the energies there are strong willed and it will require the family to stay determined to reclaim their home from them.<sup>3</sup> Regardless of this energy change I did not get any negative impressions.

**Kelly:** Upon entering the home and during set up my senses were immediately heightened. While giving Kevin a tour of the basement, my hair was on end and I felt 'charged'. The remaining areas did not pull any attention during set up. While sitting at base, the cold spot that had found me during the preliminary was back. I kept looking behind me and in the kitchen; again I was not afraid but felt as though I was being watched.

During the evening, the cold spot seemed to follow me wherever I went. And I always had the feeling I was either being watched or followed. But, as with the preliminary, it felt more curious than imposing.

At one point during the Spirit box session, I felt drawn to the living room bay window. When I looked out the window, I immediately began to feel overwhelmingly sad and felt tears rising in my eyes. At the same time [REDACTED] began to feel sick and very sad. I took [REDACTED] outside to get a breath of fresh air and clear our heads.

Upon coming back inside the home, Kevin asked me to go into the kitchen; he had felt some negative energy. When I stepped into the room, I felt the hair on my body rise and was completely 'charged'. But I can't say I felt frightened at all. We swept the room with

the EMF detector and no readings were detected. Of interest, was that [REDACTED] had indicated, at the start of the investigation, that she was uncomfortable in the kitchen.

My instincts tell me that there is more than one spirit present, certainly, an older woman, a small boy and an older man, and possibly others. None of which are harmful if the homeowners treat the spirit activity with respect and do not encourage interaction.

**Kevin:** The evening started out quiet with [REDACTED] and I in the bedroom. I did hear what sounded like a moan come from the bedroom. The night progressed with a ghost box session. I used an EM pump to help communicate with the spirits. It seemed that with every question the lights would come up to answer us.

As I sat at base station to study the monitors there was a strange sound that came from the kitchen. I investigated it right away and felt a heavy presence. It was hard to breathe and the room had an extremely hostile like feel. The kitchen was the exact opposite from the living room. It was as if it was only there to watch, not to talk. I right away called Barbara over to get her feelings and as soon as she walked in the door way her face said it all. She had felt exactly what I was feeling. I then approached Kelly to go up to the kitchen. She also greeted me with the same facial expression.

I walked away from the night feeling like there were multiple beings in the house. What communicated with us in the living room was extremely friendly and communicative.

The owner has given too many mixed signals. He said stay away from the kids' room in one session. With the next he gave permission to stay in their rooms when not home. He needs to be firm in never bothering the kids and staying out of their rooms. He also needs to let it be known not to ever touch him in any way. Communication with these beings should be halted. It is unclear the intentions of what was in the kitchen.



## **Conclusion**

The best way forward is for the homeowners to state their intentions to stay in the home in peace with the spirits, making it very clear that they can commune together as long as there are no more interactions with the children and absolutely no physical contact with anyone living in or visiting the home.

Lastly, the home owners need to discontinue acknowledging and interacting with the spirits and discourage all guests from interacting or acknowledging the spirits.

### **Post Investigation Note:**

The appendices have been omitted to maintain the privacy of the home owner.

We received many different evps and spirit box responses that were of value during our investigation. Only a few evps will be posted and those will in no way will betray location or identity of the client, their family or guest.

These evps will be class A or enhanced class B. Any enhanced audio file will be noted as such and a copy of the original will be posted as well.
